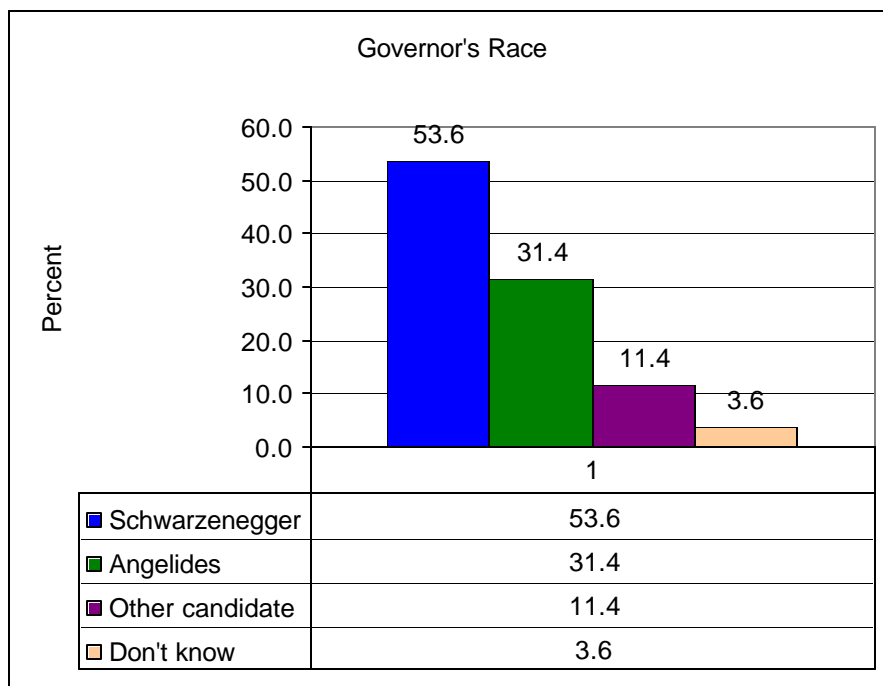

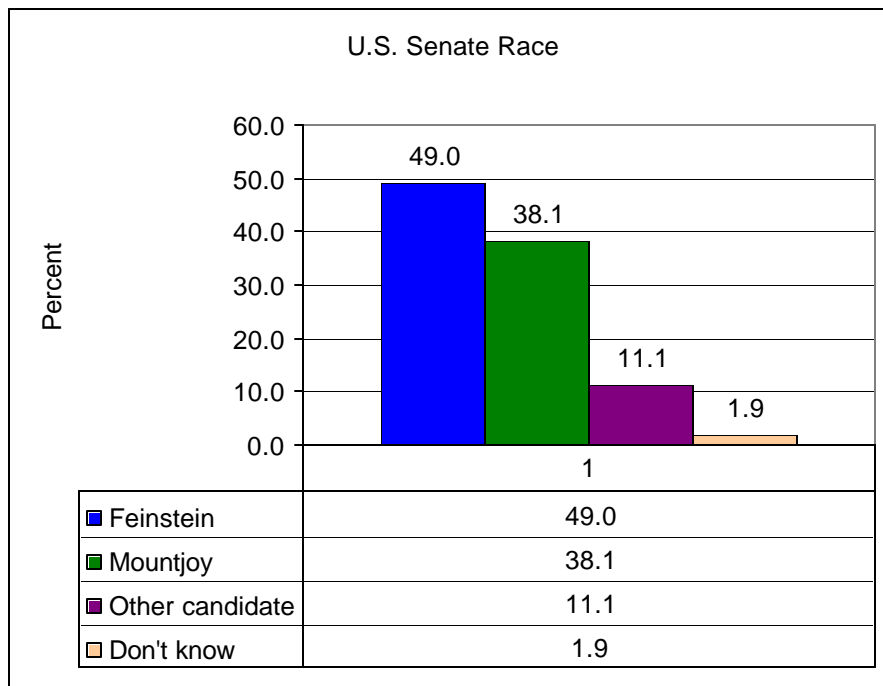
**Proposition 87 Too Close To Call**

San Diego – A poll released today by Datamar Inc., shows Governor Arnold Schwarzenegger, 53.6%, and U.S. Senator Dianne Feinstein, 49%, each with a comfortable lead among high-propensity voters who voted in the 2002 gubernatorial primary and general elections, and the 2004 Presidential primary and general elections.

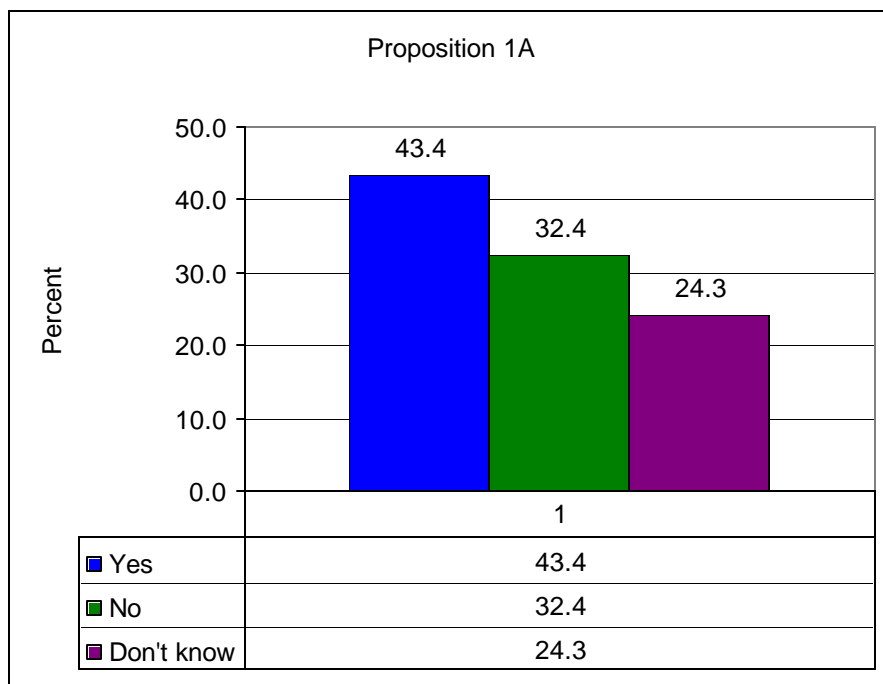
In the California Governor's race Governor Arnold Schwarzenegger leads with 53.6%, Democratic challenger Phil Angelides trails with 31.4%. Other candidates have 11.4% of the vote, and the undecided vote stands at just 3.6%.



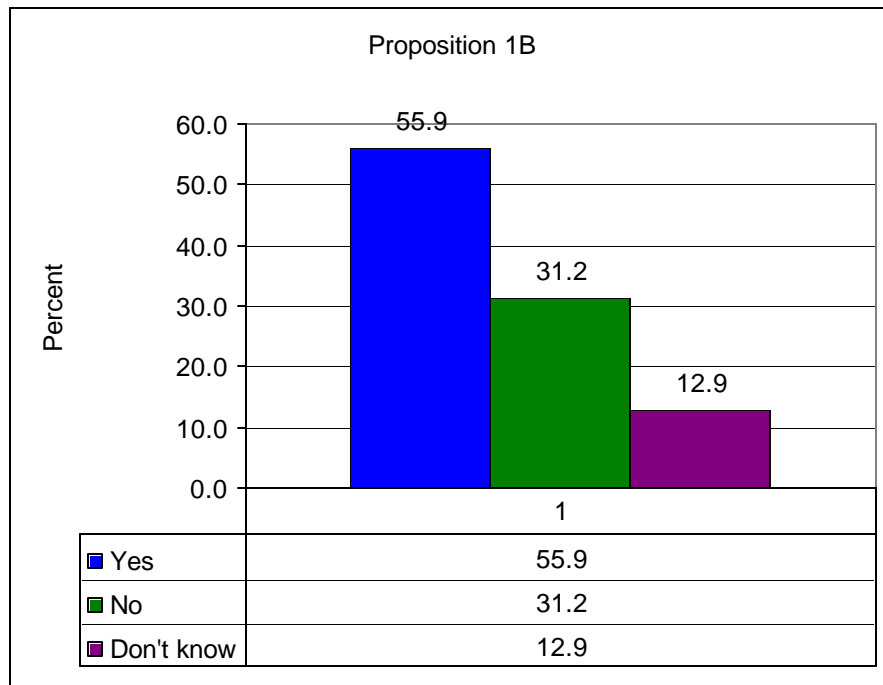
In the U.S. Senate race, U.S. Senator Dianne Feinstein is ahead with, 49%, support, while Dick Mountjoy trails with 38.1% of the voters support. Other candidates carry 11.1%, and the undecided complete the total with 1.9%.



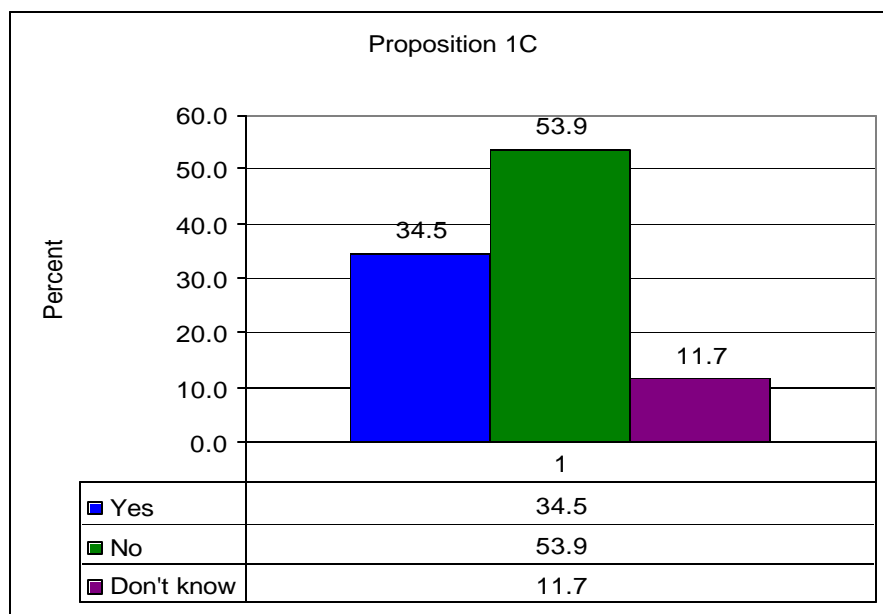
Proposition 1A, the Transportation Investment Fund which would make it more difficult for the legislature to suspend Proposition 42, which mandates that gasoline sales-tax revenues be spent on transportation, and divert money for other purposes, leads by a comfortable margin, 43.4%, in favor to 32.4% against, there are still 24.3% of undecided voters.



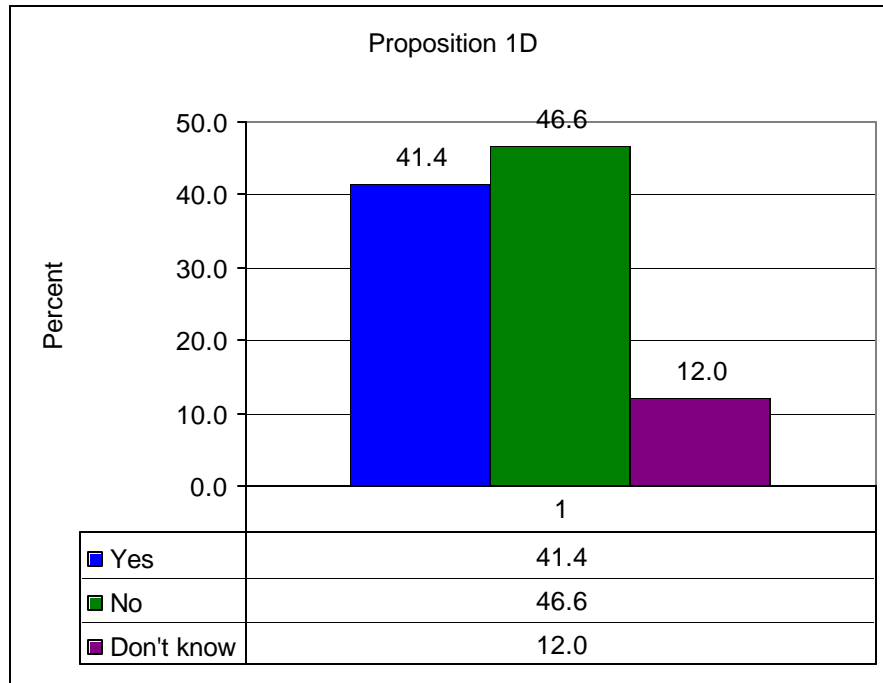
Proposition 1B, the Highway Safety, Traffic Reduction, Air Quality, Port Security Bond Act of 2006 that proposes a \$19.9 billion bond issue to pay for road repairs and expansions, repair bridges, expand public transportation and improve port security leads by a comfortable 55.9%, in favor, and 31.2% against, and 12.9% undecided.



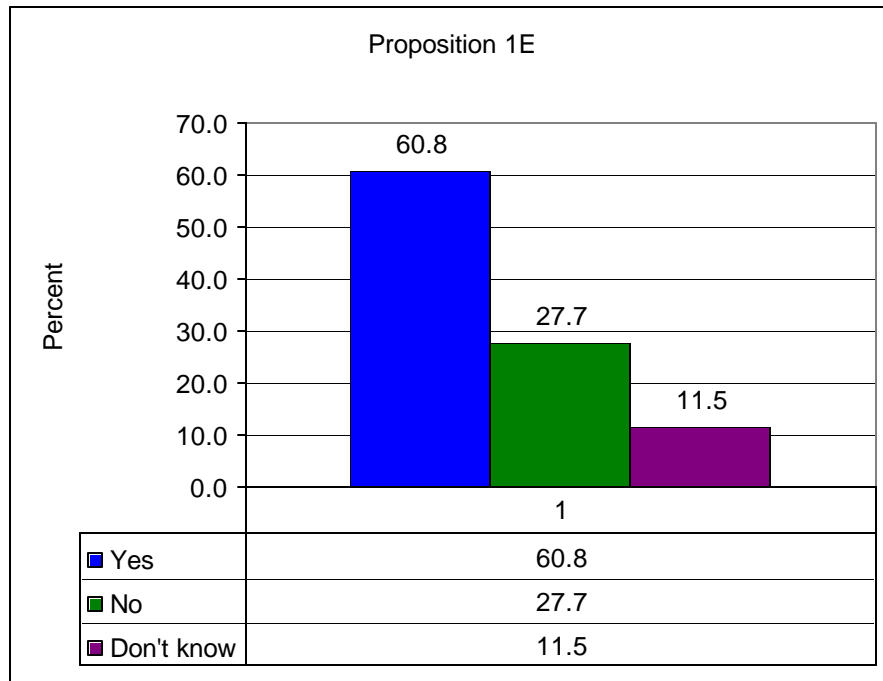
Proposition 1C, the Housing and Emergency Shelter Trust Fund Act of 2006, which proposes a \$2.85 billion bond to pay for affordable-housing assistance and housing for farmworkers and the homeless is behind 53.9% against, 34.5% in favor, and 11.7% undecided.



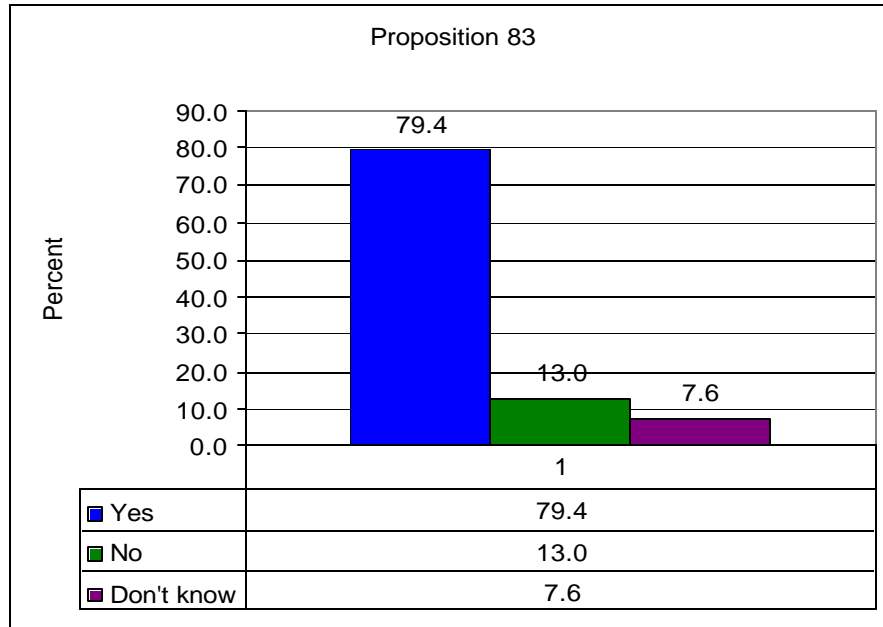
Proposition 1D, the Education Facilities- Kindergarten-University Public Education Facilities Bond Act of 2006, proposes a \$10.4 billion bond issue for school and university construction. This proposition is behind 46.6% against, 41.4%, in favor and a large 12% undecided.



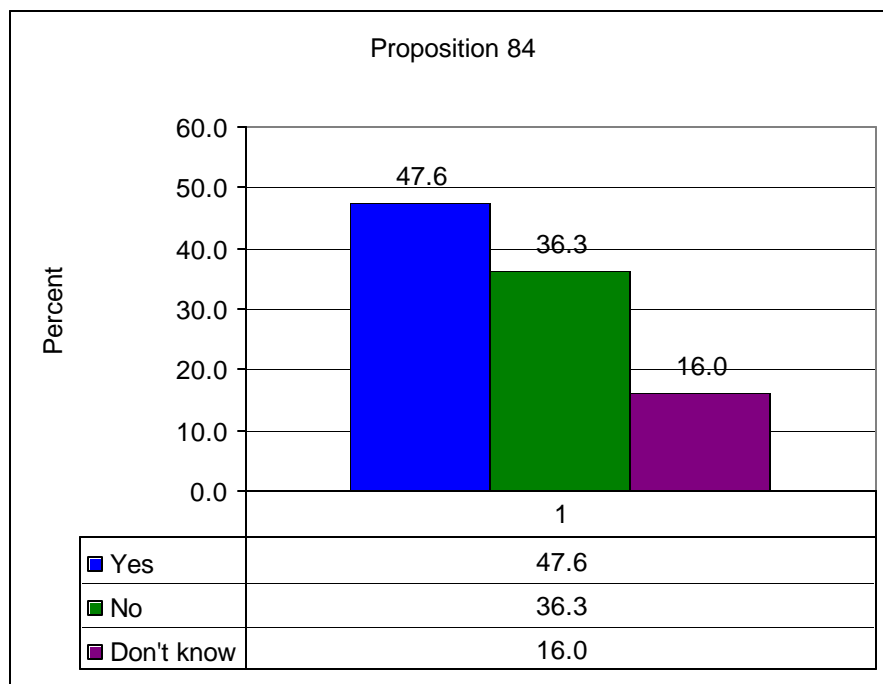
Proposition 1E the Disaster Preparedness and Flood Prevention Act of 2006 is a \$4.09 billion bond issue to repair levees and flood-control systems has a commanding lead of 60.8% in favor, 27.7% against, and an 11.5% undecided.



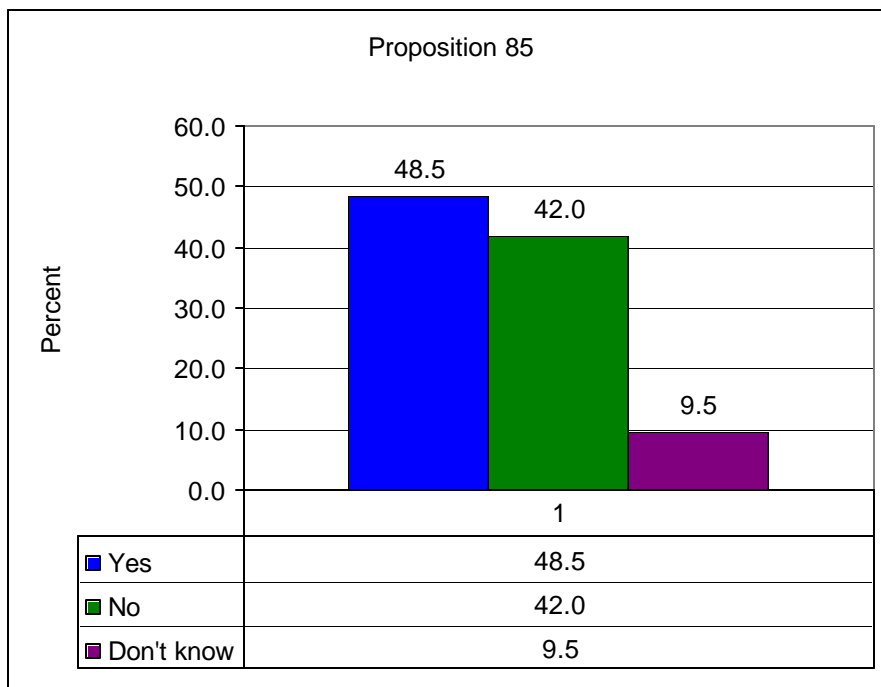
Proposition 83, sometimes called “Jessica’s Law”, is the Sex Offenders, Sexually Violent Predators. Punishment, Residence Restrictions and Monitoring. Initiative Statute. It increases penalties for violent sexual predators and child molesters and prohibits registered sex offenders from living within 2,000 feet of a school or park and requires violent offenders to wear a satellite-monitoring device for life. It is leading by an overwhelming 79.4%, in favor, a 13% against, and 7.6% undecided.



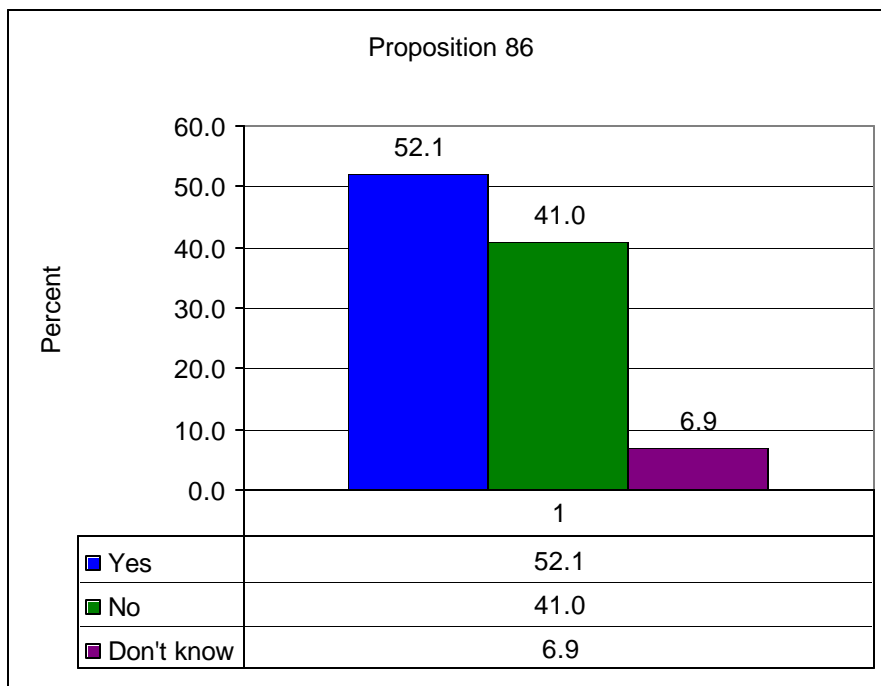
Proposition 84 is the Water Quality, Safety and Supply. Flood Control. Natural Resource Protection Park Improvement Initiative, is a \$5.4 billion bond issue to pay for clean-water, flood-control and conservation projects. Voters favor this proposition by 47.6%, in favor, 36.3% against, and a significant 16% undecided.



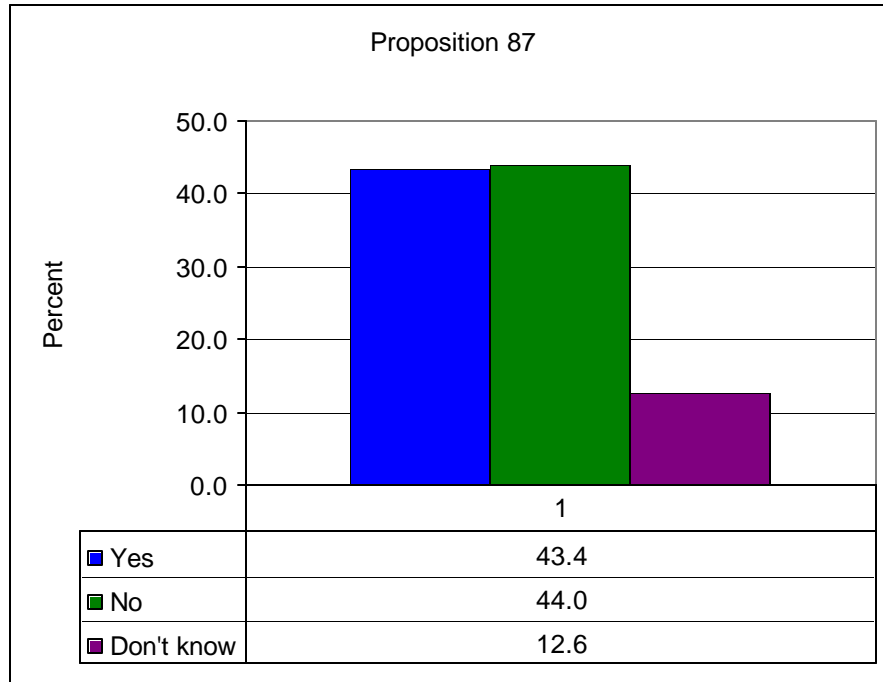
Proposition 85 is the Waiting Period and Parental Notification Before Termination of Minor’s Pregnancy Initiative and prohibits an abortion for a minor until 48 hours after a physician notifies her parent or legal guardian, with exceptions for medical emergency, parental waiver or court order. This proposition is ahead by 48.5%, in favor, 42%, against, and 9.5% undecided.



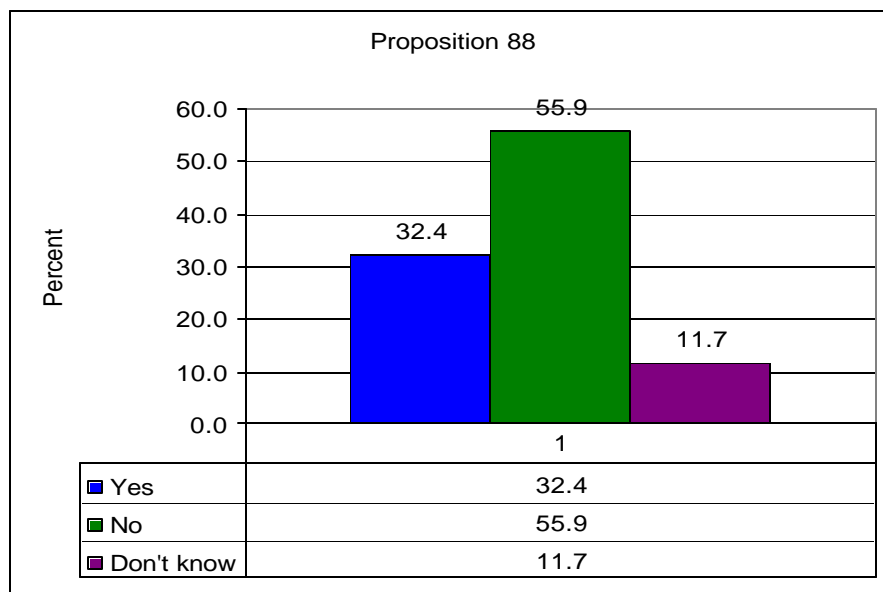
Proposition 86 is a Tax on Cigarettes Initiative. It raises the tax by 13 cents per cigarette to fund hospitals and emergency services, nursing education and children’s health insurance. This proposition is ahead by 52.1%, in favor, 41%, against, and 6.9% undecided.



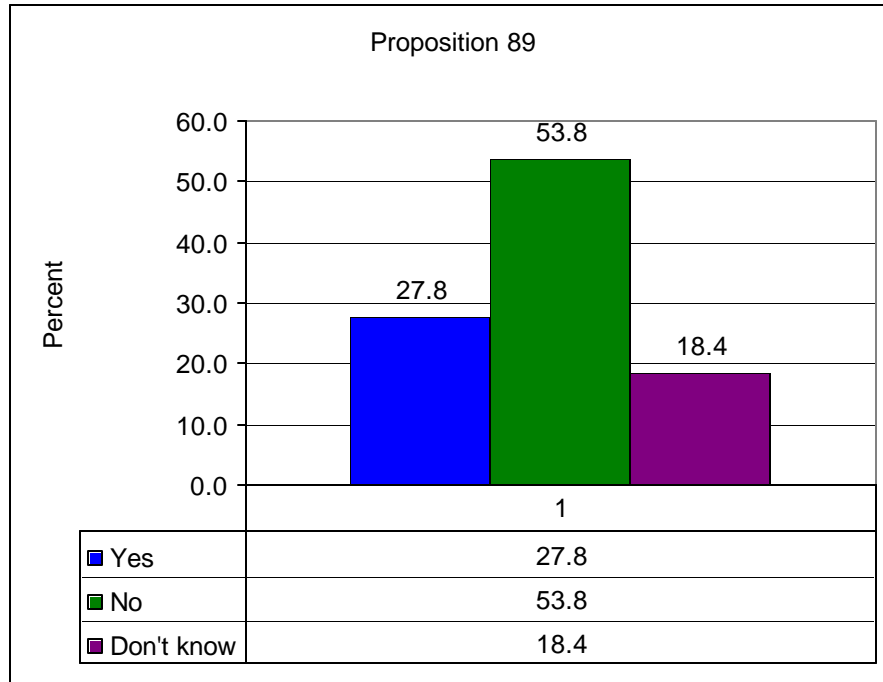
Proposition 87 is the Alternative Energy. Research, Production Incentives Initiative. It is a Tax on California Oil. It will impose a 1.6 percent to 6 percent tax on producers of oil extracted in California, depending on the price per barrel, to pay for research and production incentives for alternative energy vehicles and clean-burning fuels. This proposition is virtually tied with 43.4%, in favor, 44% against, and 12.6% undecided.



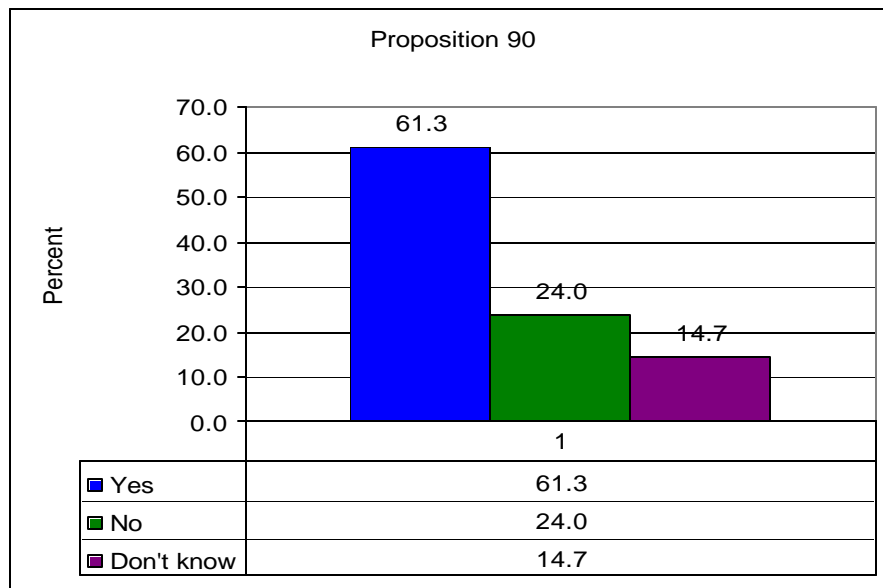
Proposition 88 is the Education Funding. Real Property Parcel Tax Initiative. It will impose a \$50 tax on each real property parcel to pay for kindergarten-through-12<sup>th</sup>-grade programs, including class-size reduction, textbooks and school safety programs. This proposition is failing with 55.9% against, 32.4% in favor, and 12.6% undecided.



Proposition 89 is the Political Campaigns, Public Financing, Corporate Tax Increase, Contributions and Expenditure Limits Initiative. It will allow political candidates who raise a specified number of \$5 donations to receive money from the state, and will raise taxes on banks and corporations by 0.2 percent to pay for the programs. Proposition 89 is significantly behind, being favored by 27.8%, 53.8% against, and 18.4% undecided.



Proposition 90 is the Government Acquisition, Regulation of Private Property Initiative. It will prohibit state and local governments from condemning private property for other private uses. Proposition 90 is significantly ahead by 61.3%, in favor, 24%, against, and 14.7% undecided.

**Methodology:** Findings are based on a September 12 - 15, 2006, automated telephone dialer survey of high-propensity registered voters in the California using the voice of a professional announcer. A Datamar proprietary algorithm was used to generate random samples of voters for calling. The margin of error for the total sample is +/- 2.3 percent at the 95 percent confidence level.

**Registered voters vs. high-propensity voters:** Registered voters who *actually vote* are significantly fewer than the voters who are registered to vote. Although it is sometimes useful to determine the opinions of all registered voters (and even the opinions of the general population), surveying the opinions of *the high-propensity voters* is more efficient and predictive for electoral/political purposes.

This survey is based on defining “high-propensity” voters as those eligible registered voters who have demonstrated high-propensity by having *actually voted* in one or more recent elections, specifically:

*Voters who voted in the 2002 gubernatorial primary and general elections, and the 2004 Presidential primary and general elections.*

Where necessary, responses were weighted according to age, gender, and political party.
